

DECLARING HYTEC POWER INC. AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) IN CONSONANCE WITH THE PROVISIONS OF R.A. 9184 FOR THE PROCUREMENT OF SUPPLY, DELIVERY AND INSTALLATION OF AGRICULTURAL AND BIOSYSTEMS ENGINEERING LABORATORY EQUIPMENT AND FACILITIES WITH TOTAL BID PRICE AMOUNTING TO ₱1,600,000.00 AND RECOMMENDING FOR APPROVAL OF AWARD

WHEREAS, the Procurement of Supply, Delivery and Installation of Agricultural and Biosystems Engineering Laboratory Equipment and Facilities has an Approved Budget for Contract (ABC) of One Million Six Hundred Twenty-Four Thousand Eight Hundred Ninety-Eight Pesos (\$\P\$1,624,898.00) sourced out from the Fiduciary Fund (FF-CROU);

WHEREAS, ASSCAT advertised the Invitation to Bid for competitive bidding in the PhilGEPS site, the agency website, Facebook Page and in several conspicuous places from August 5 to August 25, 2021 in consonance with the provision of the 2016 Revised IRR of RA 9184 otherwise known as the Government Procurement Reform Act;

WHEREAS, the Pre-bid Conference was conducted through online video conferencing on August 13, 2021 and was attended by the members of the BAC, the BAC-TWG as well as the end-user, a representative from the Commission on Audit (COA) and representatives of interested bidders;

WHEREAS, a Supplemental Bid Bulletin was issued and posted on August 19, 2021 to clarify, modify and/or amend items in the bidding document as agreed during the pre-bid conference;

WHEREAS, based on the procurement timeline, the submission and opening of bid was scheduled on August 25, 2021 where only one (1) bidder responded and submitted bidding documents namely: (1) Hytec Power Inc. with office address at #2 T. Cruz St. Cruzville Subdivision, Zabarte Road, Novaliches, Quezon City;

WHEREAS, after evaluating and checking the eligibility and technical documents submitted, the BAC then proceeded to the opening of the financial documents as follows:

- a. To declare **Hytec Power Inc.** as the Single Calculated and Responsive Bid (SCRB) in consonance with the provisions of R.A. 9184 with a total bid price of **One Million Six Hundred Thousand Pesos** (₱1,600,000.00); and
- b. To recommend for the award of the project to Hytec Power Inc. subject to the approval of the ASSCAT Governing Board.
