A. Additional Technical Specifications:

It includes the supply, delivery and installation of the following:

1. One (1) Unit 35 Feet Steel Post
2. Six (6) Units Cut-out and Arrester
3. Transformer Grounding
4. Re-installation of the existing One (1) Unit 37.5 KVA Transformer with the following specifications:
 - Frequency: 60 HZ
 - Rated High Voltage (H.V.): 7620V
 - Rated Current (Primary): 4.92A
 - Rated Voltage (Secondary): 240/120V
 - Rated Current (Secondary): 156.3A
 - Polarity: Additive
 - %IMP.VTG: 2.0 at 85°C
 - X1-X2, X2-X3 = 120V
 - X1-X3 = 240V
5. Type of Transformer : Amorphous Core Type Transformer

B. Technical Components consists of Legal and Technical Documents:

1. Any proof of Renewal such as Official Receipt, Application for Renewal and Certificate of Renewal must be attached as part of the Legal Documents for those bidders who have not yet renewed their Mayor's Permit.
2. PCAB License is not required in the Technical Documents.
