The Agusan del Sur State College of Agriculture and Technology (ASSCAT), through its Bids and Awards Committee (BAC), invites bidders to bid for the hereunder project.

Brief Description : 1 unit, 3-Storey Building (area of 515 sq.m) – Ground Floor (Windows, Door and Ceiling Works; 2<sup>nd</sup> Floor Works and 3<sup>rd</sup> Floor Concrete Slab
